Our Shade Tree Program provides shade tree education and distribution for local utility company, Salt River Project, in Arizona. Working with SRP, we help implement a valley-wide program that teaches thousands of residents how to plant trees strategically to reduce their air conditioning use while adding trees to the landscape. Residents take an hour and fifteen minute class on tree placement, planting, and maintenance, then are given 5 gallon trees to take home and plant. Annually with SRP, we distribute approximately 5,000 trees!

4b (Code: _____) (Expenses \$ 22,674 including grants of \$ _____) (Revenue \$ 20,502)

Our Edible Tree Program offers classes, hands-on workshops, tours, events and education that engage the community on the benefit of trees through food. We provide quarterly classes on edible trees, many that are not conventionally known as food producing trees. In the past year we have taught classes on various trees such as Palo Verde, Ironwood, Mesquite, and Oak (acorn). Our total attendance was around 80 people this year. We also host an edible tree program group on Facebook with 152 members and share events and information about edible trees. As a way to spread awareness and education we are developing a calendar with months corresponding with harvestable trees that include recipes. Our largest event is our annual Mesquite Pancake Breakfast where we get the community to try Mesquite and learn more about our organization.

Trees for Schools provides technical training and/or trees to schools and school districts in the Valley of the Sun. Trees Matter provided 35 trees and trained over 50 staff members at the Roosevelt School District in Fall of 2016. Our goal is to get more tree infrastructure into schools and teach staff and students the important of trees and tree care. We also developed a My Tree Activity Book that corresponds with 3rd grade level science standards but is a fun activity that can be done with family and friends too! We hope to grow this program and to focus on getting more trees in schools in the future.
